Appendix

Processing of your personal data

You have a legal right to know more about how we process your personal data, and to object to that processing. You are also entitled to complain to the supervisory authority, which is the Swedish Data Protection Agency (Datainspektionen).

Legal basis

The Environmental and Building Committee is a municipal authority that performs municipal functions in the areas of permit granting and supervisory tasks. The Committee exercises government authority in the areas of environmental and public health protection, food inspection, and building permit cases. The Committee's exercise of government authority is regulated by a number of different laws and related ordinances and regulations, such as the Planning and Building Act, the Environmental Code, the Protection against Infectious Diseases Act and the Administrative Law Act. Much of the activities of the Committee is thus based on the existence of legal obligations and the need to fulfil its tasks with regard to the public interest.

We collect the information we need in order to process your matter in an equitable manner with legal safeguards. This information may include national registration numbers, addresses, telephone numbers and real property information. The information is stored in our case management system and is archived pursuant to applicable law.

As a rule, information that is sent to us becomes public documents, which may be released pursuant to the principle of public access to official documents. We release personal data to individuals, companies or government agencies only to the extent that we are required to do in compliance with a law, ordinance or a decision of a government agency.
